Introducing NFHM co-ordinator - Susie Zada



Susie Zada is a Life Member of the Bellarine Historical Society and Honorary Life Member of the Geelong Family History Group, former member of the Genealogical Society of Victoria and currently on the committee of VAFHO and is also a member of the Public Records Advisory Council representing country Victoria and small societies throughout the state.

She has been researching her family since the late 1960s and working as a genealogist, historian and researcher since 1990. She completed an Associate Diploma in Local and Applied History at University of New England (Armidale) in 1996 and has won a number of local and Victorian awards for her contribution to local and family history. She has been guest speaker on various topics at genealogical and historical societies and community groups across Victoria and in 2002 and 2016 presented the Don Grant Lecture for VAFHO and State Library Victoria's Family History Feast.

She has worked on Heritage Studies in various municipalities in Victoria including: - Shire of Mitchell; Shire of Moira; Golden Plains Shire; City of Greater Geelong; and Moorabool Shire, as well as Conservation Management Plans for sites in Melbourne and across country Victoria.

She has researched and published several books as well as historical interpretive displays, CD-Roms, indexes and extensive web sites on local and family history. She maintains her own website www.zades.com.au with a major focus on Victoria and particularly the Geelong and Bellarine Peninsula areas containing more than 400 web pages and as at 20th March 2019 there are more than 1,720,212 entries in the main database and other sundry indexes. She is a former President of the City of Richmond & Burnley Historical Society, and the Bellarine Historical Society. She has been editor of the Geelong Historical Society journal, and was on the committee of the Royal Historical Society of Victoria History Support Group.

Paid work positions have included the Geelong Heritage Centre and the Genealogical Society of Victoria where she was initially Assistant Library Manager and later the Marketing & Administration Manager.

I'd like to bring to AFFHO organisations' attention a new resource being piloted by the National Library, to overlay NSW parish maps on current mapping.

NLA Maps Georectifier has been designed to georectify (or georeference) and publish a set of historical maps, overlaid on Open Street Map. Georectification simply means marking recognisable points on both the historical map and another map - in this case Open Street Map. The public pilot is ready for trialing and comment as of now — The public link is: http://georekt-test.nla.gov.au.

The data set currently comprises about 1000 digitised parish and town maps of NSW/ACT and nearby regions, nineteenth - mid twentieth century. Over the next six-months, we plan to add to this a layer of historical topographic maps, with wider geographic coverage. The tool allows users to setup a login to georeference the maps. Once enough points have been added, the map is then submitted for rectification and published so the map can be zoomed and viewed on current mapping.

The main target audience initially is likely to be family history researchers, but literally anyone who'd like to compare heritage mapping overlaid on current mapping, zoom in on details. Here are a couple of example published georectified maps —



Women of Franklin on the 1893 Electoral Rolls


Members of the Franklin Branch of the New Zealand Society of Genealogists have produced over 900 biographies of women enrolled in the Franklin District of Auckland, New Zealand who were listed on the 1893 Electoral Rolls. The areas covered include Pokeno, Bombay and Ramarama in the east, Tuakau, Pukekohe, Karaka, Patumahoe and across to Waiuku, Kariotahi and the Awhitu Peninsula in the west.



These one page biographies include details such as where they lived, how many children they had, if they were born in another country when they arrived in New Zealand and on which ship. You may be lucky enough to find a photograph, or a signature, a headstone and details of family members.

The area to the west of the red line is defined as Franklin.




Melbourne Rare Book Week: For the Love Of Books

FamilySearch Celebrates 20 Years Online

Salt Lake City, Utah, (23 May 2019)—Twenty years ago, global nonprofit www.familysearch.org/en launched an innovative new website, a free internet genealogy service. Two decades later, FamilySearch is a leader in the rising tide of popular ancestry-related services online. During that time, FamilySearch has



expanded and evolved its free mix of online offerings, holding true to its purpose to provide economical access to the world's genealogical records and create fun family history discoveries for everyone. (Find and share this news release online in the FamilySearch Newsroom).

On May 24, 1999, www.familysearch.org/en took the online genealogy world by storm, offering free access to hundreds of millions of historical records online—a treasure for those seeking to make family history connections. For perspective, online broadcast news, e-trading, and downloadable music services were the rage at the time. Google, ranked 93rd of top websites, was still an up-and-coming service that was attempting to redefine the role of a search engine by indexing the web to make results junk free and more consumer relevant.



From the 16th century, Portugal, Netherlands, Britain, France, and Denmark and their 'India Companies' all established a presence in these areas in pursuit of trade.

ScotlandsPeople add 1940 valuation rolls

With the addition of more than 60,000 images of the 1940 valuation rolls, containing 2.8 million entries, the collection of valuation records now extends to more than 120 million entries from 1855 to 1940.

What can you learn from valuation rolls? They tell you who owned each property, who the tenant was (if rented out), and who the occupant was (if not the tenant). And they'll also give the annual value of the property, as assessed for tax purposes.

The years of coverage are 1855, 1865, 1875, 1885, 1895, 1905, 1915, 1920, 1925, 1930, 1935 and 1940 - you can search by name or by place, and you can learn quite a lot from a free search (it costs 2 credits to view an image). www.scotlandspeople.gov.uk

Bio for speakers

Alex Tyrrell was born in Scotland, educated at Edinburgh and McMasters Universities. Prior to retirement he was an Associate Professor of History at Latrobe University. His research interests include aspects of national identity in Victorian Scotland.

Bruce McLennan is the coordinator of the Clan MacLennan worldwide project, focussing on Scottish records as well as New Zealand, Canada, Australia and the USA. He is an author and presenter at international events.

Malcolm Horsburgh has been researching his family history and genealogy for 35 years in both Edinburgh and Australia. He is a long term member of the Scottish Ancestry Group and a current member of the committee.

Ben Wilkie has an honours degree and PhD from Monash University on the history of Scots in Australia. His interests include stories of the Scottish diaspora. He is an author and past lecturer at Deakin University.

Queensland Family History Society

The Queensland Family History Society (QFHS) has made available a number of cemetery records on its website. The records are for locations in Brisbane, surrounding areas, and more distant Queensland towns, such as Wandoan.

The QFHS cemetery records include, in most cases, a full account of the monumental inscriptions. As any family historian would know, a monumental inscription can provide valuable information not available elsewhere. For example, in Wandoan Cemetery, there is a pitiful record of the Buschel family.

In Loving Memory Our Beloved Children Kenneth 11, John 10, Cheryl 8 and Russell 7 who were called home to heaven together 11 August 1964. Too dearly loved to ever be forgotten and safe in the kingdom of God. Fondly remembered by their parents

My Wife and Our Mother Ila BUSCHEL died 23 December 1979 AGE 48 years. Rest In Peace with her children.

George BUSCHEL died 10 March 1990 dearly loved husband of Ila. Father of Kenneth, Russell, Cheryl and John.

A Family together Home In Heaven

The four Buschel children, the entire family of Ila and George Buschel, were incinerated when the truck in which they were travelling collided with a goods train three miles south of Wandoan. While other available internet resources may provide information about the burials of the Buschel family, QFHS's carefully recorded transcription enables further research of events. The Wandoan Cemetery records were transcribed and prepared by Myra Phipps in 2000.

To date, QFHS has twenty cemetery transcripts available.

The Society is developing its online collections and also offers pdf versions of a number of our recent presentations. Some of the Society's Special Interest Groups have made resources available to members.


